Our pet friendly offer is subject to changes and limited availability. I hereby agree to the following regulations and conditions:

- My pet(s) are domesticated.
- I have supplied bedding for my pet(s).
 - o I understand that pet(s) should use their own bedding and are not permitted to use the couch, bed or other soft furnishings in my room as bedding.
- I understand that I will be charged fees listed below. This fee is non-refundable. I understand that additional fees may apply should my pet(s) cause any damage.
 - o Ireland (Dublin)
 - Minimum stay of 14 nights in Ballsbridge, 29 nights in Leeson St and Sandyford
 - €500 end of stay cleaning fee

- o UK:
 - Minimum say of 29 nights
 - £250 end of stay cleaning fee
- Belgium and The Netherlands
 - Minimum stay of 29 nights
 - Nightly supplement of €5 added to your room rate plus an end of stay cleaning fee of €250
- o There is no charge to bring a service animal. However, the guest will be liable for any possible damage to the property by the service animal.
 - *Rates are exclusive of tax.
- I understand that pet(s) are not permitted access to any supplementary facilities of the property, including but not limited to restaurants, bars, meeting rooms, fitness facilities.
- I must notify the Front Desk when I leave my pet(s) unattended in my room.
- I agree to be present, while any member of the personnel such as Housekeeping, Room Service or Maintenance is present in the room. Room cleaning must be scheduled for a time when my pet(s) are not in the room or the owner is present.
- I also acknowledge that if my pet(s) are not crated and are alone during housekeeping service, I will not receive service for that day.
- I acknowledge that my pet(s), if left alone in the room, should be in a pet carrier/crate.
- I agree to keep my pet(s) on a leash or in a pet carrier when transporting in & out of the property, for the health, safety, and concern of all other guests. If I fail to keep my pet(s) on a leash, the property reserves the right to ask me to leave without refund.
- I agree to accept full responsibility for any and all damages and/or unusual degree of soiling caused by my pet(s) during my stay.
- I acknowledge, that my pet(s) have received and are current with all required shots and immunizations and confirm that my pet(s) do not have any communicable illnesses or diseases. I can produce those records if required at any time during my stay.
- I acknowledge that all services recommended for my pet(s) by the property are independently owned and operated and are external to the services provided at the property.
- I acknowledge that barking, biting, and other harmful and nuisance behaviors will not be tolerated. If there is a problem, I will be asked to kennel my pet(s) or leave the property without reimbursement.
- I release the property from any and all liability for any injury and/or damage suffered by my pet(s) during my stay at the property.
- I understand and agree, that the property retains the right to exclude my pet(s) if, at the Management's sole discretion, my pet(s) are considered dangerous or is likely to frighten or harm other guests of the property.
- I agree that, should my pet(s) create any disturbances which cause complaints by other guests or personnel, at the request of Management, I shall immediately make arrangements to house the pet(s) outside of the property. Otherwise, I will be asked to leave the property without reimbursement.
- I agree to prevent noise or any further disturbance by my pet(s), in the interest of other guests. Furthermore, I agree to pay for any loss of revenue, caused by an early departure of other guests, who felt disturbed by my pet(s).

- I understand that the costs for the repair of any damages or additional cleaning requirements caused by my pet(s) behaviour and presence in the property, will be charged accordingly. This includes flea treatment of the room. I hereby authorize the property to charge my credit card for such surcharges, even if they are discovered after my departure from the property.
- I acknowledge that I will walk my pet(s) to relieve it of bodily functions on the outer perimeter of the property, away from the building facade and flower beds. I am also responsible to properly remove and dispose of any litter or waste associated with my pet(s).
- In the event of an emergency during which either my alternate contact or I cannot be reached I agree to relinquish care of my pet(s) to the property's recommended veterinarian. I release both the property and the veterinarian from any and all responsibility should any adverse situation happen while caring for my pet.
- Should the property determine, at its sole discretion, that my pet(s) are disruptive to other guests, I must immediately make other arrangements to house the pet outside the property.
- In the event that my pet(s) are left unattended and this results in noise concerns, I agree that the property will place the pet into the care of a local professional Pet Sitting Service. I accept any and all additional fees that this may incur.
- I acknowledge that the property accepts no responsibility for a pet or pet owner who does not follow the items listed on this waiver.
